



Dear Athletes and National Federations,

Thank you very much for your entry for the FEI Driving European Championships for Children, Juniors and U25 in Flyinge, Sweden from 22nd to 28th July 2024.

Please find underneath important information about the Championships.

- The timetable can be found on [Hoefnet](https://www.hoefnet.com). Tentative starting orders and other important information will also be published on the website. Please keep in mind all information is subject to change. All other official communication will be done via the official notice board and the WhatsApp group of the Chefs d'Equipe.
- Arrival is possible from 12.00PM to 20.00PM on Monday 22 July. **Earlier arrival is NOT possible.** We kindly ask you to plan your journey accordingly.
- The FEI veterinarian and FEI steward team are present to welcome you between 12.00PM and 20.00PM on Monday.
- If you arrive outside these hours - after 20.00PM for traffic or other reasons (**BUT NOT BEFORE 12.00PM on Monday**) please inform the Show Office: +36 30 9028632 (Krisztina Horváth).
- We kindly ask you to please make sure that the entry fees are paid for before your arrival to avoid any inconvenience.
- Take your horses'/ponies' temperature twice daily 3 days before coming to Flyinge! If you arrive on Monday 22 July, you must start registering temperature in the FEI HorseApp from Friday 19 July on. Make sure you fill in the Horse Health Self-certification form before arrival and bring your own thermometer with you!
- The Examination on Arrival will be done by the FEI Veterinarian before you enter the stables. This is where your horses'/ponies' passport(s) will be collected by the FEI stewards.
- First bedding for your stable(s) - 2 shavings - are included in the entry fee and will be provided. Thereafter shaving tickets can be purchased at the Show Office and can then be obtained from the Stable Manager during predetermined hours. Only pre-ordered shavings are available. **Hay is NOT available. Straw is NOT available.**
- Every competitor will receive one parking space and 1 electric hook-up per competitor is included in the entry fee. Please pick up your electrical permit in the Show Office. If you need parking for cars, please pick up a parking permit in the Show Office.
- There is no restriction on the use of (electric) bicycles. Motorized vehicles are not allowed on the showground.



- Please bring your own bridle numbers and carriage numbers.
- The marathon obstacles and sections will be officially open on Tuesday 23 July after the approval of the PGJ and TD. Exact times to be communicated via your Chef d'Equipe.
- Please note that only cones provided by the Organizing Committee are allowed.
- There is a smaller supermarket at walking/cycling distance from the showground. There are also two larger supermarkets 4000m from the showground.
- Fresh breakfast buns/breads are available at the showground every morning.
- SEK and Euros are accepted on the showground. It is possible to pay by card at the showground.
- Dogs on the leash at all times.
- No open fires are allowed on the show ground. Smoking is only allowed in designated areas.
- All drivers are taking part in the event at their own risk. The OC does not take any responsibility for any accident or illness that may befall any horse, competitor, groom or any other person.
- There is a lake at the showground. Swimming is only allowed on your own responsibility. The OC does not take any responsibility for any accidents or illness due to usage of the lake.
- No horses are allowed in the camping area. All putting into carriage needs to be done in the stable area. Carriages to be parked in the stable area.
- Each single driver (P1 & H1) will have stable accreditation (bracelets) for 5 persons, each pair driver (P2) will have stable accreditation (bracelets) for 6 persons.

More information will be provided upon your arrival in Flyinge.
